Health Care

Responsible for overseeing the health and safety of campers and staff.

Starting salary range: \$195-\$310 per week, based on position and experience.

Health Care Supervisor

Administer a health and safety program for campers and staff members and maintain records of all medical activities. Supervise and mentor Health Care Assistant. Requires state license and registration as a physician, physician's assistant, LPN, EMT, RN, or nurse practitioner. Minimum Age 21, salary starts at \$310 weekly.

Health Care Assistant

Assist in providing health and safety services to campers and staff. Supervised by a licensed physician, physician's assistant, LPN, EMT, RN or nurse practitioner. Minimum Age 18, salary starts at \$195 weekly.
