

**VOLUNTEER POSITION DESCRIPTION**  
**FALL RALLY COORDINATOR**

<b>SUMMARY:</b>	The Fall Rally Coordinator is responsible for overseeing the planning, implementation and delivery of a fun, educational, and safe event to kick off the annual Fall Program at the community level.
<b>TERM OF APPOINTMENT:</b>	The Fall Rally Coordinator is appointed for one season (September – December).
<b>ACCOUNTABILITY:</b>	The Fall Rally Coordinator is accountable to the Area Fall Product Coordinator and appropriate Product Program staff.
<b>RESPONSIBILITIES:</b>	<ul style="list-style-type: none"> <li>• Work in partnership with the Membership Director and appropriate program staff to develop customized, local events aligned to the Girl Scout Leadership Experience for Girl Scouts in the local community.</li> <li>• Recruit additional volunteers to assist in the planning and delivery of events as needed.</li> <li>• Host event planning meetings to coordinate logistics and event details.</li> <li>• Complete and submit event plan, schedule, and budget for approval prior to the promotion of the event to program staff; provide copies of all approved paperwork to Membership Director and appropriate program staff.</li> <li>• Create and submit flyers, programs and/or other printed materials to the Membership Director for approval and submission to the Council Customer Care team for printing and/or mailing.</li> <li>• Support and encourage event participants to attain desired goals and awards and provide appropriate recognitions of achievement(s).</li> <li>• Complete and submit final event report including full financial documentation to Membership Director and/or appropriate program staff within 4 weeks of the conclusion of the event.</li> <li>• Remain informed about and comply with all current policies, procedures and guidelines of Girl Scouts-North Carolina Coastal Pines and GSUSA.</li> </ul>
<b>QUALIFICATIONS AND CORE COMPETENCIES:</b>	<p><b>Girl-led Focus:</b> Empower, encourage, and guide Girl Scouts and volunteers to understand Girl Scouts' girl-led, learn-by-doing and cooperative approach to developing leadership skills.</p> <p><b>Personal Integrity:</b> Serve as a role model for volunteers guided by the Girl Scout Mission, Promise and Law - modeling reliability, dependability, honesty, credibility, respect for others, respect for self, inclusivity, positivity and a spirit of collaboration.</p> <p><b>Adaptability:</b> Adjust, modify own behavior and remain flexible and tolerant in response to changing situations and environments.</p> <p><b>Oral Communication:</b> Practice positive communication skills and express ideas clearly and accurately.</p> <p><b>Foster Diversity:</b> Understand, respect and embrace individual differences.</p> <p><b>Additional Requirements:</b></p> <ul style="list-style-type: none"> <li>• Registered member of GSUSA and a valid background check.</li> <li>• Completion of any required training assigned and provided by GS-NCCP and GSUSA.</li> <li>• Email, internet, and texting capabilities for consistent and effective communication, document sharing and research.</li> </ul>
