

Traveler Behavior Agreements



Girl Traveler Agreement:

- 1. I will uphold the Girl Scout Promise and Law and serve as a positive representative for Girl Scouting at all times.
- 2. I will be sensitive to the needs of group members and respect the places and people with whom I come in contact.
- 3. I agree to be a registered Girl Scout and wear a Girl Scout uniform or group T-shirt as per group attire decisions.
- 4. I will be responsible for my personal belongings and will not hold Girl Scouts-North Carolina Coastal Pines or my troop/group for any loss or damage. I will keep my room neat, follow the group schedule and be aware of my surroundings.
- 5. I will treat all items provided or borrowed with care. I will be assessed for damages in the event my use of such items is negligent or abusive.
- 6. I will use all required safety equipment and follow safety rules and procedures.
- 7. I understand the use, purchase or possession of tobacco, fire arms, explosives, or illegal drugs will not be tolerated, and that usage during the trip will result in expulsion from the trip.
- 8. I understand that if I am involved in misconduct, I may forfeit participation in some activities or be sent home at the expense of my parent/guardians.
- 9. I understand that I am required to have a physical examination by a physician within twelve (12) months prior to the trip.
- 10. I understand that all trip meetings are necessary and if I cannot attend, I will carefully read over and be responsible for all of the information sent out afterwards.
- 11. I agree to participate in group money-earning as determined by the group, unless I decide to pay for the trip out of pocket. If for some reason, I am unable to participate in the trip, all money earned as a result of group money-earning projects can be used for future Girl Scout related events or trips. If I decide not to continue in Girl Scouting, the money will be divided among the participants in the troop/group.
